### **What investment services and advice can you provide me?**

Our firm offers investment advisory services, which are fully described in our Form ADV Part 2A (“Disclosure Brochure”). Our services include financial planning and investment management. As part of our standard services, we monitor investments that we manage on a continuous and ongoing basis. Financial planning and investment consulting recommendations are not actively monitored. There are no material limitations on our monitoring, for example, portfolios are monitored no less frequently than annually in comparison to how well they are in alignment with your goals. We accept discretionary authority to implement the recommended transactions in client accounts. The level of discretion is determined in our agreement and there are no material limitations on the authority. We do not offer advice only with respect to proprietary products. We offer advice on mutual funds and exchange-traded funds (“ETFs”) and, on a more limited basis closed-end funds, individual bonds, certificates of deposit, actively managed funds, structured products, individual securities, and annuities (fixed, variable, and immediate). In managing client investments, the Firm also utilizes independent investment managers (“Independent Managers”). Our services are subject to a minimum annual fee of \$12,500.

### **What fees will I pay?**

---

We offer our services on a fee basis. We generally charge a fixed fee for financial planning and investment consulting and a fee based upon assets under management for investment management and wealth management services. Based on unique client circumstances and on a limited basis, the Firm may offer financial planning services on an hourly basis. For project-based services, a portion of the fees are due upon engaging us while the remainder is due upon completion of the services. In addition to the advisory fees paid to us, you also incur certain charges imposed by other third parties, such as broker-dealers, custodians, etc. These additional charges include securities brokerage commissions, transaction fees, custodial fees, fees attributable to alternative assets, reporting charges, fees charged by the Independent Managers, margin and other borrowing costs, charges imposed directly by a mutual fund or ETF in a client’s account, as disclosed in the fund’s prospectus (e.g., fund management fees and other fund expenses), deferred sales charges, odd-lot differentials, transfer taxes, wire transfer and electronic fund fees, and other fees and taxes on brokerage accounts and securities transactions.

The more assets there are in your advisory accounts, the more you will pay in fees, so the firm may therefore have an incentive to encourage you to increase the assets in your account or manage them in a way where we charge higher fees. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. ### **What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?**

**When we act as your investment adviser**, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

- Support from Custodian: We receive administrative support, computer software, related systems support, as well as other third party support from the custodian that we recommend. This results in an incentive to recommend that custodian because we do not have to produce or pay for the products or services provided.

### **How do your financial professionals make money?**

Our financial professionals are compensated based on the following factors and conflicts of interest:

- Salary. This could result in a disincentive to provide prompt service and timely investment of funds relative to commission-based compensation.
- The amount of client assets they service. This results in an incentive to favor clients with more assets being serviced.
- Revenue the firm earns from the financial professional's advisory services or recommendations. This results in an incentive to take steps to maximize revenue to the firm.
